Cashless Catering System – Biometric ID/Fingerprint Recognition

At South Bromsgrove High we use a cashless catering system in order to purchase food and drink.

A unique mathematical image is created from the fingerprint and the fingerprint is then discarded. It is not possible to recreate the fingerprint from this image.

Payments are still processed via Parent Pay.

Biometrics and Security

Students, parents and staff can rest assured that the fingerprint images cannot be used by any other source for identification purposes. The system uses an image of the fingerprint to create a mathematical algorithm and then discards the fingerprint; only the numbers remain and these cannot be reinterpreted back into a fingerprint image. You have recently received an email reminding you how the biometrics system works, but this can also be found on the school website (Life at South>Food@School). Fingerprinting is purely voluntary and those not wishing to sign up will be issued with a pin number.

We would like your consent to include your child in the Biometric registration process. If you're not happy for us to do this, that's no problem – we will accommodate your preferences.
